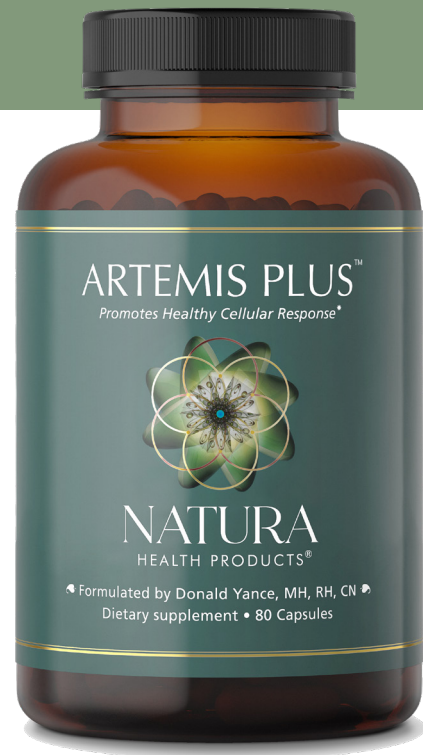

Artemisinin
